

Dürr balancing systems gearing for turbocharger market growth

Stuttgart, April 2, 2009 – Dürr is strengthening its position in the business of balancing technology for the growing turbocharger industry. By way of Darmstadt-based Schenck RoTec GmbH, the group has acquired the specialized French firm Datatechnic S.A. effective as of April 2, 2009. This rounds out Dürr's product range for balancing turbochargers.

Schenck RoTec and Datatechnic have been cooperating for a long time in the area of balancing technology for turbochargers. "The two companies complement each other superbly with their expertise in the areas of imbalance measurement and correction. Datatechnic rounds out our range of products and services ideally, so we can offer the turbocharger industry even better technology and full service worldwide," declares Ralf-Michael Fuchs, head of Dürr's Balancing and Assembly Products business unit.

Experts estimate that worldwide turbocharger production will grow by more than 40% altogether in the period to 2013. That development will be driven by the trend toward more compact and economical automobile engines, which are often equipped with one or even two turbochargers. Moreover, the market share of diesel engines with turbochargers in the United States will increase.

"Datatechnic is an optimally positioned niche supplier, and its integration will enable us to benefit above average from market growth in the turbocharger segment," says Ralf Dieter, CEO of Dürr AG. Moreover, Schenck RoTec expects to cut costs through synergy in development, purchasing, and production. Efficient development of new product generations is planned in the newly created configuration. That will mean ideally rapid reactions to the needs of the market.

Schenck Rotec is one of the world's leading suppliers of balancing technology and achieves sales of over € 180 million with about 1,000 employees.

The acquisition of Datatechnic is part of the "Dürr 2010" strategy, which guides Dürr in the pursuit of profitable growth in all six group business units.

Dürr is present in 45 locations in 20 countries around the world. The group achieved sales of € 1.6 billion with approximately 6,100 employees in 2008.
